**ORDINANCE #10-28-22A
ORDINANCE MODIFYING LOCAL INCOME TAX RATES
JASPER COUNTY**

BE IT ORDAINED by the Jasper County Council that a need now exists to modify the local income tax rates in the following way:

LIT Correctional or Rehabilitation Facilities (IC 6-3.6-6)	0.00%	0.00%
Property Tax Relief (IC 6-3.6-5)	0.85%	0.85%
Special Purpose (IC 6-3.6-7-12)	0.15%	0.15%
Emergency Medical Services	0.00%	0.02%
TOTAL	2.864%	2.864%

BE IT FURTHER ORDAINED that a public hearing was held on the proposed local income tax rate modification on October 28, 2022. Proper notice of the public hearing was provided pursuant to IC 5-3-1. This ordinance shall be effective on January 1, 2023.
